Under **Money Multiplier Scheme (MMS)**, interest shall be COMPOUNDED MONTHLY and paid on maturity.

The above revised rate of interest would be applicable for the new deposits where the credit of deposit amount comes to KTDFC bank account on or after 01.10.2018, or any renewal of earlier deposits effected on or after 01.10.2018. For the entire deposits accepted till 30.09.2018 (in case of Cheques/DDs, those realized on or before 30.09.2018) and renewal of earlier deposits with prior date, the interest rate as per earlier pattern would be applicable.
