During 2018-19, around 73 million tonne of coal was supplied to the non-regulated sector under the fuel supply agreement, out of a total coal offtake of 608 million tonne.

In a separate initiative, IPPs have been allowed for interplant transfer of coal. This means if an independent power generating entity owns two different plants and has two separate fuel supply agreements (FSA) in place, they can transfer coal from one plant to another, owned by it, to improve efficiency in generation and reduce the cost of the fuel.
